**Øystein Kock-Johansen** is Professor, dr.philos in archeology, graduated archaeologist, and historian of religion and economics. Most of his life he has worked as a researcher, fieldworker and expedition participant - for many years with Thor Heyerdahl. He has written several books.



**Ihab Timraz** is senior consultant for the Executive Master of Management section of the Norwegian Business School. He was from 2005 to 2007 Head of Corporate Governance for Norges Bank Investment Management (NBIM), which manages Europe's largest sovereign wealth fund, and he continued until 2009 as an advisor and consultant on social issues for NBIM.

Henrik has written several books and articles in the fields of philosophy, politics, and ethics. The World Economic Forum in Davos nominated him as a Young Global Leader in 2007, and he is a frequently used lecturer in Norway and abroad. He has been a member of the Norwegian Press Complaints Commission since 2002 and a member of the Norwegian Nobel Committee, which awards the Nobel Peace Prize, since 2015.
